The first is process wastewater that is discharged directly to a private third-party wastewater treatment facility operated on an adjacent property - the wastewater discharge from that facility is the responsibility of the third party operator and is not part of this P2 Plan. The second wastewater stream from the Site is included in this P2 Plan, and consists of wastewater from toilets/sinks/bathrooms/kitchens in the facility, as well as boiler blowdown water - this wastewater stream does not contain any process wastewater.
